## **TERMS OF REFERENCE**

The consulting services ("services") include support to the Eswatini Water Services Corporation (EWSC) with the design review, contractor procurement documents, assistance during procurement, construction supervision, contract management and project management for the Ezulwini Sustainable Water Supply and Sanitation Project. The duration of the assignment is expected to be 14 months, excluding the defect liability period. The scope of the project includes, but is not limited to; design review and construction supervision of a 15ML post tensioned reinforced concrete reservoir, access road, water kiosks and a 2 km long 500mm diameter delivery main.

- c) Experience of having **successfully completed** at least 2 assignments of a similar nature and size with FIDIC Red Book Contract during the period from 2015 to 2020(Y/N)
- d) The Consultant's relevant personnel must possess Bachelor Science degrees in their fields of study and be professionally registered with relevant internationally recognised professional councils or bodies (Y/N)
