2. Instruction to Bidders

1.Qualification of the Bidder

 - (c) experience in works of a similar nature and size for each of the last two years, and details of work under way or contractually committed; and clients who may be contacted for further information on those contracts;
 - (d) major items of construction equipment proposed to carry out the Contract;
 - (e) qualifications and experience of key site management and technical personnel proposed for the Contract;
 - (f) reports on the financial standing of the Bidder, such as profit and loss statements and auditor's reports for the past two years;
 - (g) evidence of adequacy of working capital for this Contract (access to line(s) of credit and availability of other financial resources);
 - (h) authority to seek references from the Bidder's bankers;
 - information regarding any litigation, current or during the last five years, in which the Bidder is involved, the parties concerned, and disputed amount; and

(i) proposals for subcontracting components of the Works amounting to not more than 10 percent of the Contract Price. The Employer will respond to any request for clarification received earlier than 28 days ¹ prior to the deadline for submission of bids. Copies of the Employer's response will be forwarded to all purchasers of the bidding documents, including a description of the inquiry, but without identifying its source.
7. Amendment of Bidding Documents	Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda. Any addendum thus issued shall be part of the bidding documents and shall be communicated in writing or by cable to all purchasers of the bidding documents. Prospective bidders shall acknowledge receipt of each



addendum by facsimile to the Employer. To give prospective bidders reasonable time in which to take an addendum into account in preparing their bids, the Employer shall extend, as necessary, the deadline for submission of bids. 8. 9. Bid Prices	The Contract shall be for the whole Works, based on the priced Bill of Quantities submitted by the Bidder.
	The Bidder shall fill in rates and prices for all items of the Works described in the Bill of Quantities. Items for which no rate or price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed covered by the other rates and prices in the Bill of Quantities.
	All duties, taxes, and other levies payable by the Contractor under the Contract, shall be included in the rates, prices, and total Bid price submitted by the Bidder.
	The rates and prices quoted by the Bidder shall not be subject to adjustment during the performance of the Contract.
10. Bid Validity	Bids shall remain valid for a period of 90 days from date of tender opening.
	In exceptional circumstances, the Employer may request that the bidders extend the period of validity for a specified additional period. The request and the bidders' responses shall be made in writing. A Bidder may refuse the request without forfeiting the Bid Security. A Bidder agreeing to the request will not be required or permitted to otherwise modify the Bid, but will be required to extend the validity of Bid Security for the period of the extension.
	In the case of contracts in which the Contract Price is fixed (not subject to price adjustment), if the period of bid validity is extended beyond 60 days, the amounts payable to the Bidder selected for award, shall be increased by applying the factors specified by the GCC.
11. Bid Security	The Bidder shall furnish, as part of the Bid, a Bid Security

in local in the amount specified in the tender advertisement.

The Bid Security shall, at the Bidder's option, be in the form of a certified check, bank guarantee or insurance bond from a reputable Guarantor acceptable to the Employer. The format of the Bid Security should be in accordance with the form of Bid Security included in this tender document or another form acceptable to the Employer. Bid Security shall be valid for 28 days beyond the validity of the Bid.

Any bid not accompanied by an acceptable Bid Security shall be rejected by the Employer.

The Bid Security of unsuccessful bidders will be returned within 28 days of the end of the Bid validity period as specified in the tender advertisement.

The Bid Security of the successful Bidder will be discharged when the Bidder has signed the Agreement.

The Bid Security may be forfeited

- (a) if the Bidder withdraws the Bid after Bid opening during the period of Bid validity;
- (b) if the Bidder does not accept the correction of the Bid price, or
- (c) in the case of a successful Bidder, if the Bidder fails within the specified time limit to sign the Agreement.

12.Format and Signing of Bid

The Bidder shall prepare one original of the documents comprising the Bid as described in these Instructions to Bidders, bound with the volume containing the Form of Bid, and clearly marked "ORIGINAL." In addition, the Bidder shall submit a copy of the Bid, and clearly marked as "COPIES." In the event of discrepancy between them, the original shall prevail. The copies are to be used as working documents while the Originals will be kept by

the Employer for record purposes.

The original and all copies of the Bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign on behalf of the Bidder. All pages of the Bid where entries or amendments have been made shall be initialed by the person or persons signing the Bid.

The Bid shall contain no alterations or additions, except those to comply with instructions issued by the Employer, or as necessary to correct errors made by the Bidder, in which case such corrections shall be initialed by the person or persons signing the Bid.

13.Sealing and Marking of Bids

The Bidder shall seal the original and the copy of the Bid in two separate envelopes duly marking the envelopes as "ORIGINAL" and "COPY" respectively.

The envelopes shall;

- -be addressed to the Employer at the address provided in the tender advertisement.
- -bear the name and identification number of the Contract as defined.
- -provide a warning not to open before the specified time and date for Bid opening.

In addition to the identification required, the envelopes shall indicate the name and address of the Bidder to enable the Bid to be returned unopened in case it is declared late.

If the envelopes are not sealed and marked as above, the Employer will assume no responsibility for the misplacement or premature opening of the Bid.

14. Deadline for Sub-mission of Bids	Bids shall be delivered to the Employer at the address specified in the tender advertisement and no later than the time and date specified. The Employer may extend the deadline for submission of bids by issuing an amendment, in which case all rights and obligations of the Employer and the bidders previously subject to the original deadline will then be subject to the new deadline.
15. Late Bids	Any Bid received by the Employer after the prescribed deadline will be returned unopened to the Bidder.
16. Bid Opening	The Employer will open the bids, in the presence of the bidders' representatives who choose to attend at the time and in the place specified in the tender advertisement. The bidders' names, the Bid prices, the total amount of each Bid, the presence or absence of Bid Security, and such other details as the Employer may consider appropriate, will be announced by the Employer at the opening. The Employer will prepare minutes of the Bid opening, including the information disclosed to those present. Bids not accompanied by the required documentation will be rejected at opening and returned to their owners.
17. Process to be Confidential	Information relating to the examination, clarification, evaluation, and comparison of bids and recommendations for the award of a contract shall not be disclosed to bidders or any other persons not

officially concerned with such process until the award to the successful Bidder has been announced. Any effort by a Bidder to influence the Employer's processing of bids or award decisions may result in the rejection of his Bid.

18. Clarification of Bids

To assist in the examination, evaluation, and comparison of bids, the Employer may, at the Employer's discretion, ask any Bidder for clarification of the Bidder's Bid, including breakdowns of unit rates. The request for clarification and the response shall be in writing, telex, or facsimile, but no change in the price or substance of the Bid shall be sought, offered, or permitted except as required to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the bids.

19. Correction of Errors

Bids determined to be substantially responsive will be checked by the Employer for any arithmetic errors. Errors will be corrected by the Employer as follows:

- (a) where there is a discrepancy between the amounts in figures and in words, the amount in words will govern; and
- (b) where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern, unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted will govern, and the unit rate will be corrected.

The amount stated in the Bid will be adjusted by the Employer in accordance with the above procedure for the correction of errors and, with the concurrence of the Bidder, shall be considered as binding upon the Bidder. If the Bidder does not accept the corrected amount, the

Following the contract award decision, the client will prepare a notice indicating the name of the best evaluated tenderer, the value of the proposed contract and any evaluation scores. The notice will be sent to all tenderers who submitted tenders by letter and, where appropriate, by fax or email; and will be Published on the Eswatini Public Procurement Regulatory Agency website.

The Client will allow a period of at least ten working days to elapse from the date of dispatch and publication of the notice before a contract is awarded.

The contract will be awarded following negotiations. After negotiations are completed, the Client will promptly notify other consultants on the shortlist that they were unsuccessful and return the unopened Financial Proposals of those consultants who did not pass the technical evaluation.

Occupational Health, Safety and Environment Policy Requirements for Tendering for All Eswatini Water Services Corporation Projects and Works



Pricing

 As specified in the Bid Data Sheet (BDS) and Particular Conditions (PC), prices shall be fixed and firm for the duration of the Contract, or prices shall be subject to adjustment, in which case the provisions of GC, Adjustments for Changes in Cost, shall apply.
- 5. Bid prices shall be quoted in the manner indicated and in the currencies specified.

For each item, Bidders shall complete each appropriate column in the respective part of the BOQ/Schedules, giving the price breakdown as indicated.
